# 4. Presentation by Janet Neale, WCC

- Excellent and very detailed talk given by JN on S106 details and her responsibilities, including all monitoring of monies involved
- Any future questions or clarifications we may have can be emailed directly to JN
- JN had sent out (circulated to Councillors) a detailed spreadsheet with all Welford relevant S106 items
- The S106 process starts with initial planning applications (both local & neighbourhood) and progresses through until all monies have been "spent" This can be up to 10 years.
- Various subsections of allocation eg education, roads, paths, biodiversity etc etc. Each
  of these has a "complex" formula based on the number of houses and locality to the
  development site. Usually, a minimum of 10 houses is required but this can be
  reviewed.
- Developers' contributions don't always arrive on time but WCC can forward fund if necessary
- JN will send WPC an example from Dunchurch for requests for a youth club and library
- Need to request the £4929 for path from Kehlstein (ACTION: CIIr M Lake)
- Use neighbourhood plan for requesting monies. Need to make it visible Suggested "Parish council response to development" (ACTION: Clir S Carter)
- Need an update twice a year (ACTION: CIIr M Lake)
